City Manager Kelly Kuentler, ACM/HR Director Crystal Caldera, City Secretary Sandra Passailaigue, City Attorney Denise Frederick, Public Works Director Melinda Moritz, Assistant Public Works Director David Dimaline, Community Development Manager Megan McLeod, Police Chief Joe Salvaggio and Fire Chief Luis Valdez were also in attendance.

Leon Valley City Council will host a citizens' communication meeting to hear citizen issues and provide general policy and factual information as to issues brought up by citizens. No action will be taken except to place an item on a future agenda as appropriate.

Items Identified for possible discussion:

Presentation of the plan to install new flood/storm siren at the Public Works Complex. L. Valdez and Mr. Ivan Ortiz of the Texas Water Development Board. Fire Chief Luis Valdez (Fire Chief Luis Valdez)

Fire Chief Luis Valdez gave a brief presentation on the City of Leon Valley's new early flood/storm siren which was installed at the Public Works building at 6429 Evers Rd. on March 9th, 2017. The new siren system was provided in part through an approved grant from the Texas Water Development Board, and will better notify residents that live near the park of impending flooding or of other severe weather. This project will work in conjunction with and also update the existing siren (located along El Verde Rd.), and be more efficient by adding a remote activation feature. This feature allows Leon Valley's Firefighters and Police Officers to activate both sirens remotely, while in the field.

Presentation of Live Streaming Options for City Council Meetings. (ACM/HR Director Crystal Caldera)

ACM/HR Director Crystal Caldera gave a presentation on livestreaming options for City Council meetings. The purpose of the presentation was to provide these options and to determine the urgency of this objective. Option 1 was (Swagit, Rushwork or Grancius); Option 2 was Accela which the City is currently using for agendas and minutes; Option 3 was a Public Access Channel or "PEG"; and Option 4 was to wait until a future date to explore more options. The consensus was to move forward with Accela.

Waste Management Contract Discussion (Assistant Public Works Director David Dimaline)


City Manager Kelly Kuenstler gave a presentation on the current solid waste contract and surveyed those in attendance on what they were looking for in a provider. 53% said they preferred a once a week pickup; 68% of those who wanted twice a week pickup said they would be willing to pay more for an additional pickup; 100% said they wished to continue recycling; 64% said they would like a composting option in the upcoming contract; and 63% said they would like a pay option based on usage.
